### INFORMATION ABOUT CAL CITY PERMIT PROGRAM

California City has been one of the fastest growing areas for Off-Highway Vehicle families to enjoy OHV recreation. Riders throughout the state come to California City for its easy access for R.V.'s and Toy Haulers. There are hundreds of miles of dirt routes that are open for riders. These routes are ideal for all levels of experience and lead to other advance trails in the RANDES MOUNTAIN trail system. The City has opened marked "Blue" trails into California City for visitors to enjoy local establishment. Riders must stay on marked trail system when entering the main part of the City. Please read the back of your receipt for important laws and local ordinances pertaining to OHV use in California City.

Effective **March 2008** all Off-Highway Vehicles **MUST** display a "California City – Street Operating Permit" while being operated in California City. This permit allows OHV's to operate on **DIRT ROUTES** that are within the designated riding area. Any dual-sport or street licensed vehicle DOES NOT need an operating permit.
